

Did the Pope Allow Blessings of Same Sex Unions?

On December 18, The Dicastery for the Doctrine of the Faith issued a document signed by Pope Francis called *Fiducia Supplicans*. This led to a firestorm of headlines in the media and strong reactions from Catholics. Catholics should look to the Catholic Church as a rock of moral clarity, and many are confused, angered, or saddened about what some may see as a change in the Church's position on same-sex unions. I encourage you to prayerfully reflect on the following points to gain a clearer understanding of *Fiducia Supplicans*.

First, certain media headlines were false. For example, an ABC News headline said, "Pope says priests can bless same-sex unions." In paragraph 5, the document states, "The Church does not have the power to impart blessings on unions of persons of the same sex." This document opposes the practice of some German bishops who began blessing same-sex unions. Articles in the media often lack the proper clarity necessary when dealing with a nuanced topic like this.

Second, Fiducia Supplicans upholds Church teaching on marriage. Paragraph 4 defines marriage as the "exclusive, stable, and indissoluble union between a man and a woman, naturally open to the generation of children—and what contradicts it are inadmissible. This conviction is grounded in the perennial Catholic doctrine of marriage; it is only in this context that sexual relations find their natural, proper, and fully human meaning. The Church's doctrine on this point remains firm." Fiducia Supplicans tries to be clear that it is not changing Church teaching.

Third, context is helpful. Pope Francis goes to great length to reach out to people who are estranged from the Church. A good shepherd will seek out the lost sheep; the heart of every Christian should have a desire to seek the lost. *Fiducia Supplicans* makes some distinctions about blessings in an attempt to offer "simple gestures" to reach out pastorally to some who are estranged or might feel excluded from the Church.

If Church teaching isn't changing, what is new in this document? This document makes some distinctions regarding blessings. The Church cannot bless same-sex unions, but the Church does routinely offer non-liturgical blessings to individuals, even individuals who might be in a state of sin. Think of those who can't receive the Eucharist but come up for a blessing. *Fiducia Supplicans* discusses a third category: a couple that "recognizing themselves to be destitute and in need of his help—do not claim a legitimation of their own status, but who beg that all that is true, good, and humanly valid in their lives and their relationships be enriched, healed, and elevated by the presence of the Holy Spirit" [31]. The blessing suggested here isn't a blessing for the same-sex union, but for the couple seeking God's help. Ultimately, although this is not stated in the document, the couple would need to repent and become chaste friends or end their relationship in order to be truly "enriched, healed, and elevated."

Do Catholics need to agree with this document's pastoral approach on blessings of same-sex couples? No. Pastoral approaches are not the same as Church doctrine, and they do not fall under the charism

of infallibility. Catholics can legitimately agree or disagree on the best pastoral approach for dealing with situations. In evangelization, there is a delicate balance between the need for clarity on moral teachings with the need to reach out to the broken and meet them where they are. Some may agree with the approach presented in this document, while others may think it is dangerous to "blur the line" by blessing same-sex couples. Some Catholics in good standing argue that, because of the connection between being a same-sex couple and being in an objectively immoral relationship, it is dangerous or even scandalous to use the language of blessing a same-sex 'couple.' Whether we agree with the Holy Father's pastoral approach or not, we still should show him respect and offer him our prayers.

We should be prepared for what will come about in the aftermath of this document (abuses and misunderstandings are already widespread). Catholics can rightly wonder if the Dicastery anticipated that this document would be misused to advance agendas that are contrary to the teachings of the Catholic Church and the good of society.

Fiducia Supplicans states that it is seeking to prevent scandal. "Precisely to avoid any form of confusion or scandal, when the prayer of blessing is requested by a couple in an irregular situation, even though it is expressed outside the rites prescribed by the liturgical books, this blessing should never be imparted in concurrence with the ceremonies of a civil union, and not even in connection with them. Nor can it be performed with any clothing, gestures, or words that are proper to a wedding. The same applies when the blessing is requested by a same-sex couple" [39]. These requirements are already being violated by priests who are publicly doing blessings contrary to the stated intent of this document. Unfortunately, the world may not hear the nuanced distinctions Fiducia Supplicans attempted to make.

My heart goes out to those who are distressed or shaken by *Fiducia Supplicans*. To anyone who might be wavering in their faith because of it, I hope this letter gives you assurance that the Church's teaching is not changing. Feel free to discuss this further with me or Father Lindle. *Fiducia Supplicans* is not a step that will eventually lead to a change in Church teaching, and no faithful Catholic is being asked to compromise on Catholic doctrine. Five, ten, or a hundred years from now, the Church teaching will remain the same. For our part, we must not give in to fear or anxiety, nor to an attitude of anger towards others in the Church. Trust in Christ's promises, and keep your focus on living your vocation to holiness. Do not allow the chaos of the times to undermine your peace in Christ and our mission to live for the glory of God and His Kingdom.


